MOTION TO APPROVE MEETING MINUTES: Commissioner Washington made a motion to approve the minutes of the February 12, 2019 regular HA meeting and seconded by Commissioner Carlamere. Said motion passed unanimously.

EXECUTIVE DIRECTOR'S REPORT-

We met with the cleaning company and have created a weekly schedule outlining what will be done each day of the week and signed off by the office at the end of the week. We have contacted a local contractor who will present a quote for the concrete problem areas. We are submitting a CDBG application to the Township requesting \$75,000.00 for masonry, painting of common areas, and painting of 25 units. We are looking into other options to replace the postage machine. The State will do a file and physical inspection on June 6. The peeling of the columns at the resident entrance must be repaired before then. Housing Authorities are required by legislation to conduct an annual audit. However, our budget cannot withstand the cost.

- Tenant expressed concern about the doors to the courtyard being left open or unlocked. The
 office will speak to the cleaning and maintenance companies since this is the door used to remove

- Tenant addressed an issue with her heater. A work order will be enter a work order. Tenant also asked about removing stains on the carpet in the common areas. We have a shampooer and will inquire with the cleaning company about scheduling.

Tenant asked if anything can be done about lowering the switch to turn on the exhaust fan over the stove as it is impossible to reach. The fans are installed at a standard height. We are unable to remedy this.

Asked if the tenant is responsible for moving the furniture when the apartment is painted. Tenant will not be required to move furniture.

#110 - Judith Melvin

When are the smoke detector batteries changed? They are tested and changed regularly. Detectors were replaced with new ones last year. Batteries are only for back up. Detectors are hard wired.

There was discussion of the garden boxes and who will be responsible for tilling and adding fresh soil. It will be taken care of.
