EXECUTIVE DIRECTOR'S REPORT – Mr. Snyder and Ms. Cutter reported on the following:

- Community Relations officers from the GT Police Department met with tenants on June 5th to
 discuss senior safety measures as the result of an anonymous letter received by the mayor's office
 regarding safety concerns. Residents were instructed not to let individuals in the building who
 they don't know. Officers also discussed various scams that target seniors. Management has taken
 several measures to keep residents safe including an updated security camera system and the
 FOB access system. Residents should be responsible as well.
- Flooring on 1st floor and in all laundry and recycling rooms will be replaced at the end of June.
- There is additional funding available from CDBG funds, so the plan is to replace the carpet on other floors once bid documents are prepared.
- Met with HVAC contractor to discuss results of bi-annual preventative maintenance. There are two common area condensers requiring replacement. There are also a few apartment units that will require additional work.
- Proposal received to paint the Woodbury Turnersville side of the building. DCA inspectors who
 came out in February suggested this be done.
- Landscapers weeded all beds and mulched property. Township Public Works is doing a fabulous job mowing the lawn.
- Residents requested sun umbrellas in courtyard at the patio tables. Approval was given to purchase the umbrellas.
