MOTIONS:

1. <u>Motion to Approve Meeting Minutes</u>: Commissioner MacPherson made a motion to approve the minutes of the Regular Meeting held on September 12, 2023. Commissioner Rossell seconded the motion. Said meeting minutes were approved unanimously.

<u>RESOLUTION 23-10-10-2</u> — Approving a contract for flooring replacement. Commissioner Guevara motioned to approve the awarding of the flooring contract to Barton Carpets and seconded by Commissioner MacPherson. Said motion passed unanimously.

EXECUTIVE SESSION – NONE

EXECUTIVE DIRECTOR'S REPORT – Mr. Snyder reported that the approval of the flooring contract covers the replacement of carpet on the 2nd and 3rd floor common areas and the community room. This project is funded by CDBG funds. Mr. Snyder further reported that all repairs from the lightning strike had been completed except the nurse call system. Ms. Cutter added that the nurse call system was scheduled for replacement on October 19th. Additionally, Ms. Cutter reported on the solar panels and advised that an inverter and meter were down which is why there have not been any proceeds received this year. Ms. Cutter further reported that the insurance claim was submitted to cover the damage of the lightning strike.

<u>COUNCIL LIAISON</u> — Councilwoman Grace thanked Ms. Cutter for her handling of the lightning strike disaster. She further reported that the Township Trunk or Treat is being held on October 27th.

<u>MOTION TO ADJOURN</u> – A motion to adjourn the meeting at 6:11 PM was made by Commissioner Rossell and seconded by Commissioner Guevara. Said motion passed unanimously.
